

He was also a profound thinker with a marvelous wit, and I always welcomed his insights and enjoyed our many conversations over the years. And as his friend, I can attest to what a devoted father and husband he was. Anyone who knew him knew that his family was the center of all he did. I find it difficult to put into words how much his loss has impacted me and our entire college community. He was a truly remarkable person, and we are all worse for having lost him.

Matt and I were hired together by MCC's English/Philosophy Department twenty years ago but I still remember the physical thrill of his intelligence, his commitment to his students, and his compassionate political views. He met my husband almost immediately, I met Regina, and we got to know Rochester together. We bought our first homes in the same city neighborhood, we took care of each other's cats. We learned about whiskey together. Regina and I talked about Days of Our Lives. Matt and Regina talked about Star Trek. We all talked about theatre. Then, life twisted and turned, as it does. We sold our homes, moved to other parts of the area. Sophie came along, then Evie, then Henry. We didn't see each other as much.... We *all* are better for having been touched by Matt's mind, his wit, his love.

Matthew Hachee was hired at MCC upon the retirement of philosophy professor, Derek Harrison. At the time, our country was thick in another war. Derek, a close family friend, and I were part of a weekly Saturday morning peace vigil. It wasn't long after Matt and Regina moved to Rochester that Derek dragged Matt along to the vigil, and it was on that line—a public statement for peace and justice—where I spent the majority of my time with my new colleague.

Matt Hachee had a commanding presence. If you ever met him, you know exactly what I mean. He got bigger when he spoke, and whoever was within earshot would instinctually lean into his words. His orbit of energy was expansive, though he was never

loud or overbearing. His intellect, his aura, his very spirit took up space. His presence was always generous. To my knowledge, Matt gave everyone the benefit of the doubt. There may have been some philosophical undergirding to this magnanimity he shared with everyone, but I can't say for sure. Matt's presence and words decorated a room to feel regal. I have yet to meet another human being like Matt.

Over the years, the war ended (sort of). He and I were busy with our young families and professional interests that didn't permit much intersection. Until recently. I found my way to Faculty Council, and, shortly thereafter, Matt found his way back to the group. In our Faculty Council meetings, Matt raised our standards of, well, everything. His presence—even when



calling in on zoom—made me want to be a better thinker, a more generous colleague, a reliable union leader. Matt believed in pooling our collective intellect and fierce spirits to do good by MCC, our students, our colleagues, and for the greater society.

Last summer, we both attended a NYSUT leadership conference. We shared a meal, and I remember at the time thinking, *There is no place else I want to be. There's so much I want to talk with him about.*

We talked some that evening and caught up a bit on several years of life and family. For the rest of the conference, Matt was not feeling well and was unable to participate in the goings-on. Like the rest of us, I thought we would have more time to connect, more long conversations about life, love, justice, union solidarity, and so much more. These would be conversations I looked forward to, like a cold drink of water after a long and dusty journey. But now, I, we, must carry on and try to realize the values that mattered to him, even with this lingering thirst for his presence.

Candidate for VP for Teaching Faculty, Jennifer Hill

This is the 7th "Candidate Statement" I have submitted to serve the Faculty Association. I have been involved with the FA for 14 of the 17 years I've been at MCC. I am proud of the work we have done, and I have thoroughly enjoyed (almost) all of it. But I'm tired. I believed a decade ago that I would serve as President of the FA. These last 10 years have been tough at MCC. And I've also learned that, mentally and physically, I cannot serve as President. I'm not being humble. I'm not looking for compliments or for people to convince me I should serve in this role. We have been cajoling and begging our members to increase their participation in the FA for years, but too many of you are satisfied letting others do this work. I am sorry if my honesty is hurtful. I know we all feel that our "initiatives" here at MCC are valuable and super important. I think you would be hard-pressed to find one group or committee on campus that has more of a direct impact on members than the FA and our role in negotiating contracts, filing grievances,

advocating for our members, and fostering an equitable and fair workplace and policies. For too long, this work has fallen on only a few shoulders.

The FA is about to hit a critical tipping point. Our amazing leader, Bethany, has also warned you for years that she too will step down as President soon. It's hard for me to imagine what the FA looks like without Bethany at the helm but imagine it and live it... we will.

A colleague of mine summed up the atmosphere: MCC and our employees are "languishing". I get it. Times have been challenging. We've lost students, faculty, and staff and maybe our interest in "Inspiring Everyday". MCC is not what it used to be but that does not mean that it cannot be something good and pride-invoking again. But that will require US to make that happen. By reengaging, by collaborating, by working to improve the college for US and our students.

Please vote for me for my 3rd term as Vice President for Teaching Faculty. More importantly, considering getting involved with the FA and/or encouraging colleagues to get involved. The time to pass the buck is over.

Candidate for Secretary/Treasurer, Jeff Baker Our MCC Faculty Association and its statewide affiliate, NYSUT, have made significant gains during the past year. Locally, we signed a new contract that guarantees pay increases for five years and relieves some of the uncertainty we faced in the recent past. Statewide, NYSUT has achieved increases in funding for higher education, helping to avoid the financial problems faced by public colleges in other parts of the country. As a member of the Faculty Council and FA negotiation team, I played a small role in helping to achieve those milestones. But there are still goals to reach, and I am asking you to allow me to continue working toward them.

This is my 22nd year at MCC, having served as an adjunct faculty member and temporary fulltime faculty. I have taught at other community colleges, four-year colleges, and universities and worked as professional staff at a liberal arts college. This brings a wide range of perspectives on issues that MCC has in common with other institutions, and on concerns unique to us.

While serving on the MCC Faculty Council for 9 years, I attended eight NYSUT Community College Conferences as well as NYSUT trainings, rallies, issues meetings, demonstrations, and legislative activities. Other FA experience includes serving on two negotiating teams, communication, and adjunct sub-teams, and as chair of the adjunct faculty committee. I have produced and conducted FA workshops for faculty. My leadership experience also includes having served as president of the New York State Conference of the American Association of University Professors (AAUP) which is both a faculty/staff union and nondisciplinary professional organization, and as president, treasurer, and trustee of the Learning Disabilities Association of New York State. I have completed AAUP leadership and negotiation training, and I have been a member of the AFT Adjunct Faculty Caucus. I would appreciate your vote.

Candidate for Diversity & Inclusion Chair, April Daniels

In my candidacy statement two years ago, I wrote that the ESOL/TRS department carries out the very mission of diversity, equity, and inclusion at our institution, in spite of systemic and structural barriers within higher education. I noted that as a faculty member of this ever-evolving department, I am fortunate to be a member of a hard-working team that lives these ideals consciously through its pedagogy, curriculum, and professional development. This is still true, and I am committed to growing this work.

I currently serve DEI initiatives at the college as a senator; as the co-chair of the Inclusion, Diversity, Equity, and Accountability (IDEA) council; as a member of the Diversity, Equity, and Inclusion Workgroup: DEI in Teaching and Learning; as a member of the Truth and Racial Healing Toolkit core team; and as an active

member of the TCC. In these various roles, I have had the opportunity, along with other devoted faculty and staff across the college, to identify equity gaps and areas for improvement, and to advocate for equitable policies, procedures, and practices. I have recently been nominated to become a member of the NYSUT Standing Committee on Civil and Human Rights, whose charge it is to "advance the union's efforts to promote equity and social justice," and whose recommendations are forwarded to NYSUT's officers and board.

In my previous candidate statement, I wrote that as a proud alumna of MCC, I had the great fortune of exposure to equity-minded faculty, and that they set me on the difficult path toward equity. I said that their examples are what both sent me forth and brought me back, and that I am duty-bound to continue their work. This is more true today than it was two years ago, in part due to the alarming rise in incidents of hate; discriminatory legislation; and attacks on DEI initiatives and academic freedom. It would be my honor to continue the work of those who have gone before me to advance equity.

Candidate for Teaching Director, Jim McKenna

I have a record of staunch commitment to MCC's students, faculty, and staff. A past Senator for two and a half terms, I served on the Curriculum Committee and SCAA. While on SCAA, I participated in multiple searches for dean positions and on the search for our first provost. Additionally, I intentionally act in the best interest of our college community. I am Faculty Liaison to the men's basketball team, acting as a mentor, counselor, and trusted friend to our student athletes. I collaborate with outside agencies to train our students in the use of Narcan and arrange for a retired federal bankruptcy judge to educate MCC students about credit card debt and credit abuse.

My master's is in Drug and Alcohol Counseling. I have the ability to nurture productive working relationships in small and large groups and communicate effectively with multiple

constituencies. My varied experience with constructive interactions has benefited the Faculty Association and the entire college. My commitment to MCC's students, faculty, and professional staff has always been unwavering. As many of you know, I have had the privilege of representing you at the bargaining table during the previous negotiations. This was at times challenging and stressful. The team did a fantastic job negotiating with administration. We fought hard for the contract. As you are well aware the team negotiated a five-year contract. I am now completing my third term as Treasurer. I now have decided to step down from that position. Since becoming involved in the Faculty Association the past eight years have been extremely important to me. At this time, I would like to continue my involvement and would ask you to support my running for the open Teaching Director position.

Candidate for Professional Staff Director, Melissa Santiago

Candidate for Downtown Site Director, Antonia Custodio

In my 30 years at MCC, I have worked at the Downtown Campus where I started at Damon when we were in the Sibley Building. Having started as a receptionist in the Student Services Department I learned how to value the work we did and continue to do and that is to serve our students. Students are at the heart of what we do but so are our faculty and staff. I have served as a Representative for CSEA and was on the negotiating team. I've served on Faculty Senate, the MCC Strategic Plan, and the Accreditation Committee. I am currently serving on the Downtown Campus Leadership Team, the Diversity, Equity, and Inclusion Council, Chair of the Latino Affinity Group, the Sustainability Committee, and a number of searches and other committees. My passion is MCC but more specifically the Downtown Campus. In my role

as Facilities Director for the Downtown Campus, my goal is to provide a welcoming and clean environment for everyone we serve on a daily basis. My daily walks throughout the campus and the many meetings I attend give me the opportunity to interact with many at the Downtown Campus. Many reach out to me daily for requests, concerns, and suggestions. I am an advocate for our Downtown Community and want to continue to do that in this role. I have not served in any capacity on Faculty Council, but I look forward to serving should I be selected for this position and continue to be an advocate for the Downtown Campus.

Candidate for Adjunct Chair, P.J. Ciaccia

As general background, I have worked in a variety of clinical settings and taught at several academic institutions—being part of the adjunct faculty at MCC since 1994. My most extended employment (over 30 years) was working as a psychologist for NY State. My latter years with the state were largely focused on the clinical/forensic needs of a special population—a population having a variety of dealings with law enforcement.

During my entire state employment, I was a proud member of the Professional, Scientific and Technical Services Unit (PS&T) of the Public Employees Federation, AFL-CIO. As such, I repeatedly became aware of the need for strong advocacy by the union to ensure that the standards of care always remained high and that those providing such services required both professionally autonomy/flexibility in the administration of their services and to be appropriately compensated for those services. These same general needs are also necessary to ensure the quality of education we provide for our students.

Thanks to the persistent efforts of the FA, we at MCC have a new contract. Although that is formally resolved for the time being, we must ensure that all aspects are maintained at the prescribed levels—remaining vigilant in an everevolving academic environment. As Jeff Baker, the current Adjunct Chair, has stated, the "MCC

Faculty Association and its statewide affiliate, NYSUT, have made significant gains during the past year" regarding funding. However, he has also shared how we are still underfunded, especially from the county. Stressing the importance of this is crucial to ensure continued quality for our students and adequate compensation for those providing that education. The latter is especially problematic given the challenges he has identified, "decreasing enrollment" as well as the aforementioned underfunding. I believe this is a highly accurate analysis and, in my role as Adjunct Chair, would provide all possible assistance in addressing the above issues.

I have been a liaison between the adjunct faculty in Psychology and the department for over 10 years. However, the scope of this office goes well beyond those concerns...despite how important those concerns are. Nonetheless, I would be quite happy to embrace the aforementioned challenges if given the opportunity. Thankfully, if allowed to assume the position, Jeff has agreed to act as mentor/guide. The latter should dramatically reduce my time in "coming up to speed" and thus effectively discharging the duties of the office. Finally, I do thank you for your consideration.

Candidate for Legislative Chair, Joe Scanlon

I am asking for your vote for the Faculty Association Legislative Chair position for the 2023-2024 year. As Legislative Chair, I aim to identify and work with candidates and officials supportive of MCC's mission and goals, the role of the FA at the College, and labor unions in general. Adjunct Advocate – Jeff Baker, Adjunct Chair

As an adjunct faculty member, you have the right and ability to be found by students and college personnel. The Faculty Association Contract provides:

Article 32 - Section B

3) Listing in College Publications. All adjunct faculty shall have an opportunity to be included and listed as such in the College Directory. After four (4) cumulative semesters of employment, adjunct faculty shall have an opportunity to also be listed in the College Catalog if they request such listing.

Why is this important? Students need to find you if they have questions and college staff may need to find you for many different reasons.

Once a class begins, students will have your Course Information Sheet (syllabus) showing your contact information. But what if a student wants some information before enrolling in your class or someone who is not a student needs to contact you for routine college business or in an emergency? Although a knowledgeable and persistent person

can go through the campus operator, find the department chair or secretary and eventually find you, it is much easier if you are listed in the college directory.

To see if you are listed, go to the <u>directory</u> and either search the alphabetical listing by the first letter of your last name or check the department listing. If the link does not work, go to the college website and scroll to the bottom of the home page for the Directories link. If your name is not there, ask your department secretary to have you added to the listings.

While listing in the college catalog is less important, it is a matter of recognition and once you meet the requirements, you should request that as well. For both the directory and catalog, it is important to follow up because the college has not been very diligent in implementing such requests.
