FA Scholarship Committee Updates

The FA Scholarship Committee has been working hard this fall semester with fundraising and scholarship development. This upcoming spring 2024 semester, we will be awarding two scholarships: the *Faculty Association Follow Your Dream Scholarship*, honoring the late Rochelle Watson-Payne, and the *Matt Hachee Memorial Scholarship*, in honor of the late Matt Hachee.

The Faculty Association "Follow Your Dream" Scholarship focuses on students who may have obligations outside of the classroom, such as caring for family members/children or working multiple jobs to make ends meet, while continuing to succeed at MCC.

Each year, the scholarship names an honoree who has contributed to the success of the MCC students and the college community. Rochelle Watson joined MCC in 2004 as a technical assistant in the Integrated Learning Center. She was promoted to full-time instructor then to assistant professor in Transitional Studies. Rochelle achieved associate professorship in 2018. Rochelle made a positive impact on her students by always keeping their best interests at the forefront, providing an enhanced and rewarding learning experience.

Matt Hachee joined MCC in 2003 as an instructor teaching Philosophy. In 2013, he achieved associate professorship. Matt had the ability to explain complex abstract ideas and make complicated topics accessible for students in his introductory-level classes. His energy and enthusiasm in the classroom were invigorating and infectious. Matt was a valuable contributor not only to his department but to the entire College community. He was a founding member of the Sixth Act and the Scholars' Day Committee. He was active in the Honors institute; the Holocaust, Genocide and Human Rights Project; and served on Faculty Council for many years. He was a valued member of the FA leadership team.

Both Rochelle and Matt made a lasting impact on students, employees, and the entire MCC community.

Communication Tip from the FA Mediation Team

Effective communication is a skill that can significantly impact both personal and professional success. Whether you're navigating workplace dynamics, building relationships, or resolving conflicts, your ability to communicate clearly and authentically plays a pivotal role. Here's a key communication tip to enhance your skills:

Embrace the Power of Non-Verbal Communication

The art of communication involves more than just choosing the right words. Embracing non-verbal cues will elevate your interpersonal skills and contribute to your overall success. While words convey the explicit message, non-verbal cues often communicate the underlying emotions and intentions. Paying attention to your body language, facial expressions, and gestures, and being attuned to those of others, can improve the effectiveness of your communication.

- 1. **Maintain Eye Contact:** Establishing and maintaining eye contact demonstrates confidence and sincerity. It conveys that you are actively engaged in the conversation and attentive to the speaker.
- 2. **Posture and Gesture:** Be mindful of both. Open and relaxed posture indicates approachability and receptiveness, while crossed arms or fidgeting may convey defensiveness or discomfort.
- 3. **Facial Expressions:** Your face is the number one nonverbal communication message sender. Ensure that your facial expressions align with your words to convey authenticity and transparency.
- 4. **Tone of Voice:** You know the saying... "It's not what you say, but how you say it." The tone in which you speak can significantly impact the perceived meaning of your words. Be mindful of your tone. Ensure it aligns with the message you want to convey.

From AFT: Public Service Loan Forgiveness

Here's why it is critical that you apply for PSLF before the end of 2023:

The AFT settled a landmark court case in October 2021 that set in motion significant, but temporary, changes to the eligibility requirements for Public Service Loan Forgiveness. Since that time, we have heard from hundreds of members who have had their entire loan balances wiped away thanks to our union's efforts.

If you have student debt and, like most AFT members, work for a public employer or nonprofit organization—regardless of whether you work in education, healthcare or another profession—you could have your entire debt balance forgiven, but YOU MUST APPLY before the end of 2023 to benefit from the temporary PSLF waiver and income-driven repayment readjustment. This now applies to Parent Plus Loan borrowers, but only for a limited time!

You *do not* have to have made 120 payments over 10 years to benefit from this temporary waiver right now. Even if you have only made some payments to qualify for PSLF, applying before the end of the year may move you significantly closer to achieving loan forgiveness because you may get additional credit for MORE payments AND for periods of deferment or forbearance that exceed 12 months consecutively or 36 months total. Don't miss out. Apply before the end of 2023 if you want to take advantage of the temporary PSLF waiver and income-driven repayment adjustment.

Here are steps you can take now to make sure you're on the right path:

- Use the U.S. Education Department's <u>PSLF help tool</u> to start your application right away.
 - Create or log in to your Federal Student Aid account. This is where your federal student loan information is available from the Education Department. The help tool walks you through the necessary steps to apply for Public Service Loan Forgiveness. Create your account or log in here.
 - Fill out the online portion of the PSLF application.
 - Once you've completed the help tool, download and print out the autogenerated form. Have your employer(s) sign page 2. Each employer you are trying to certify will need to sign their own page 2. Then submit the form to MOHELA, using the submission instructions at the top of page 4 on the form.
- Need more information? Attend an AFT virtual student debt clinic for more details about how these programs work and what you can do to qualify. Sign up for an upcoming virtual clinic here.
- Sign up for <u>Summer</u>, the free AFT member benefit that helps you navigate your student loans. Summer provides information and additional support to help you navigate applying for PSLF and other loan forgiveness options.

AFT Resolution: Condemning Hate and Affirming Freedom of Speech on Campus

WHEREAS, intellectual freedom is foundational to a representative democracy and enshrined in the First Amendment freedoms of speech and expression, conscience and assembly; and

WHEREAS, people cannot truly exercise their rights without the open and robust debate of ideas, free from intimidation, violence and threat of violence; and

WHEREAS, U.S. colleges and universities, both two-year and four-year, are central to the development and promotion of intellectual freedom and should be sites of free and open debate, where difficult—sometimes painful—topics and opposing ideas should be discussed, challenged and debated in ways that respect diversity of thought and the dignity and humanity of all; and

WHEREAS, to secure this freedom of thought and expression, institutions of higher education have an obligation to ensure environments where students, staff and faculty are free to engage in these exchanges without facing intimidation or racially, politically or religiously motivated attacks and threats of violence; and

WHEREAS, faculty, staff and students have both rights and obligations in the exercise of intellectual freedom, including the responsibility to exercise their freedoms in ways that respect the rights of those with whom they disagree; and

WHEREAS, higher education as a site of free speech and protest is even more essential and necessary during times of unrest and uncertainty; and

WHEREAS, misinformation campaigns and legislative attacks are used to stoke the culture wars on campus and continue a cycle of hate and bigotry that has resulted in an increase in racism, antisemitism, Islamophobia and anti-LGBTQIA+ hate on campus; and

WHEREAS, the violence, threats of violence and intimidation we recently have seen on campuses create an environment that puts students, faculty, staff and other members of the campus community at risk, making it an environment where freedoms are undermined, our country further divided, and our democracy further eroded; and

WHEREAS, students, faculty, staff and other members of campus communities have been subject to social media attacks, doxing campaigns and death threats; and

WHEREAS, faculty and staff have faced discipline, pressure to resign, and termination as a result of exercising their academic freedom in the classroom and their right to engage in protest and speak out:

RESOLVED, that the American Federation of Teachers will continue to condemn hate in all its forms, affirm the dignity and humanity of all, and promote intellectual freedom and First Amendment freedoms as foundations of our democracy; and

RESOLVED, that the AFT will continue to fight hatred, racism, antisemitism, Islamophobia and anti-LGBTQIA+ hate and will vigorously defend the free speech rights of higher education students, faculty and the community, including the rights to peacefully assemble and protest, as well as defend our members who face discipline or termination of employment as a result of their protected speech or their participation in lawful protests on campus; and

RESOLVED, that the AFT will call on college and university administrations to respect academic freedom and debates on campus; to condemn hate and racially, politically and religiously motivated attacks; and to ensure the safety of all members—whether teaching, working or learning—of the campus community; and

RESOLVED, that the AFT will provide sample resolutions, workshops and guidance to our locals and state federations to support this work at the campus level.
